

2025 Jewel-Osco Kick off Captain Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR TO WIN THE JEWEL-OSCO/ KICK OFF CAPTAIN SWEEPSTAKES (THE "SWEEPSTAKES"). A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING.

Once on-line at Jewelkickoffcaptain.com, you will be asked to enter your zip code and the weekly prize code. You will then be routed to enter the sweepstakes. PRIZES & APPROXIMATE RETAIL VALUE: (7) Grand Prizes (one per Drawing Date) consisting of: Four (4) tickets and (1) Parking pass to 2025 regular season Chicago Bears home football game at Soldier Field in Chicago, IL that corresponds with the winner's Drawing Date, in-stadium recognition of the eligible child on the video board, and one (1) replica Chicago Bears Jersey for the eligible child (approximate retail value of \$499 per prize).
